Technical comment:

page 4 clause 6.1 table 1

**The identifier of LATIN CAPITAL LETTER Y WITH DIAERESIS (bit combination
10/15) should be corrected to U+0178.**

The proposed value U+00AF is the identifier for MACRON.

Editorial comment:

Referenced standards should be written correctly.

page 2 clause 3.

**"ISO/IEC 8824:1995...Abstract Syntax Notation One(ASN.1)" should be "ISO/IEC
8824-1:1995, Information technology - Abstract Syntax Notation One(ASN.1):
Specification of basic notation"**

page 6 clause 7.2.

"ISO/IEC 8824" should be "ISO/IEC 8824-1"

page 8 ANNEX B

**"ISO/IEC 10646-1...Architecture and Multilingual Plane." should be "ISO/IEC
10646-1...Architecture and Basic Multilingual Plane."**



>
> It is the US long stated position that additional parts of ISO/IEC
> 8859 should not be created, except to capture existing 8-bit practice.
> Rather than addressing problems with particular solutions which are
> costly to implement, industry efforts should be focused on
> implementing a comprehensive solution via the support of ISO/IEC
> 10646. All Celtic characters in 8859-14 are in 10646.
>
> The adoption of ISO/IEC 10646 by the vendor community is making rapid
> process. Therefore it can not be argued that new 8859 parts must be
> accepted for lack of practical alternatives. As an intermediate
> solution, the new character set can be registered for consistent
> implementations.
